
Standards change...

- The standard metre is also a formula based on physical constants
- There are no constants in finance
 - Markets change...
 - Regulations change
 - Business models change...
 - ...so standards change



The Evolution of FIX

FIX standards have driven electronic trading for 30 years and are constantly updated to support industry needs



- Over 150 messages, 6000 fields, covering...
 - General communication
 - Market data
 - Order management & trading
 - Static data
 - Counterparty management

- Reporting
- Post-trade processing
- Collateral management
- Position management
- New protocol features supported in earlier versions
- Separation of business model, encoding and session
- Interoperability with third party standards



FIX is dead?




Working with ISO

- FIX already has two ISO standards
 - Tag-value encoding ISO 3531-1
 - The standard FIX session ISO 3531-2
- Working on becoming a 'publicly available standards' submitter at JTC1
 - Simple binary encoding
 - Orchestra
- Joint expert group with ISO on FIX/ISO 20022 interoperability
 - Initial focus on core trading
- Key roles in ISO 20022 governance
